
Sir,

This is with reference to earlier circular letter No. HRM-V/12(2)2004/32917 dated 06.08.2009. To remove the ambiguity, it is informed that the Executive Committee, Central Board of Trustees, EPF in its 66<sup>th</sup> meeting held on 3<sup>rd</sup> July 2009 has approved the delegation of financial /administrative power in case of indoor medical treatment taken by the retired employees of EPFO and/or their spouse/dependents under CS(MA) Rules, 1944.

1.	Additional Central Provident Fund Commissioner (Political State)	Full powers in respect of all the Group A Officers within his jurisdiction including the Zonal Vigilance Directorate located in his/her region
2.	Regional PF Commissioner-I	Full power in respect of all the Group B,C & D Officials under his/her control
3.	Director, NATRSS	Full powers in respect of Officers and Staff working in the NATRSS & ZTIs.
4.	Additional Central Provident Fund Commissioner (HR)	Full powers in respect of Group 'A' Officers upto RC-I in Headquarters.
5.	Regional PF Commissioner (ASD)	Full powers in respect of Group B, C & D employees in Headquarters.

The above arrangement would be in place with immediate effect.
