Sub: **Forwarding of proposal for Modified Assured Career Progression (MACP) Scheme in respect of Direct Recruit Stenographers**

Sir,

Please refer to this office circular letter no. HRD/4(1)2009/Misc./Circular/10359 dated 26.5.2009 vide which the Scheme of Modified Assured Career Progression as made applicable to Central Government employees was circulated.

Some of the provisions of the above scheme are highlighted for ready reference:-

- (i) This MACP Scheme has become operational w.e.f. 1st September 2008.
- (ii) First Financial upgradation under MACP shall be allowed after completion of 10 years service from the date of appointment as a direct recruit.
- (iii) An official who has completed 10 years/20 years/30 years of regular service in the same grade would get one financial upgradation by getting the next higher scale of pay.

With a view to consider the cases of the officials who have completed 10 years regular service as Stenographers(DR Quota) by 31.03.2009 under the Modified Scheme of Assured Career Progression, you are requested to forward the required details in the Proforma enclosed as an Annexure-I in respect of Stenographers working under your administrative control alongwith a statement showing their respective ACR gradations for the last 5 years from 2004-2005 to 2008-2009, Vigilance Clearance/Integrity Certificate etc.

You are accordingly, requested to send the requisite details on priority basis so as to convene the meeting of the Screening Committee to consider all such cases for the purpose of grant of benefits under Modified Assured Career Progression Scheme.


In case, any official, who being otherwise eligible for financial upgradation, under the erstwhile ACP Scheme upto 31.8.2008, has not been granted the same, his/her case with the required details be also forwarded to the Head Office for consideration.
