
**Sub:- Re-allocation of jurisdictions of Internal Audit Parties as per geographical nearness of the offices to their Headquarters.**

In partial modification earlier Office Order No. HRD/P-IV/1(7)99/108679, dated 24.03.2008 locating the Internal Audit Parties on creation of 11 additional Audit Parties, the jurisdictions of Internal Audit Parties are hereby re-allocated keeping in view the geographical nearness, easy availability of man power, avoidance of overlapping in other's jurisdiction, the jurisdictions of Additional CPFCs, easy accessibility to all offices in the respective jurisdictions from a Central location etc. As under:-

Sl. No.	Internal Audit Party with Headquarters at	Revised Jurisdiction
1.	Delhi-North	Delhi-North, Delhi-South, NATRSS, Head Office, The EPF Appellate Tribunal and Uttarakhand.
2.	Faridabad	Faridabad and Gurgaon Regions in Haryana and the Zonal Training Institute, North Zone, Faridabad.
3.	Kanpur	Kanpur and Meerut Regions in Uttar Pradesh.
4.	Chandigarh	Chandigarh and Ludhiana Regions in Punjab and Himachal Pradesh Region
5.	Hyderabad	Hyderabad, Guntur and Nizamabad Regions in Andhra Pradesh.
6.	Bangalore	Bangalore, Mangalore and Peenya (Bangalore-II), Gulbarga in Karnataka Region and Goa Region.
7.	Chennai	Chennai, Tambaram and Madurai Regions in Tamil Nadu and the Zonal Training Institute, South Zone, Chennai.
8.	Coimbatore	Coimbatore Region in Tamil Nadu and Kerela Region.
9.	Patna	Bihar, Jalpaigure in West Bengal and North East Region and the Sub-Zonal Training Institute, Shillong in NER.
10.	Kolkata	Kolkata Region in West Bengal and Jharkhand Region and the Zonal Training Institute, East Zone, Kolkata.
11.	Ahmedabad	Ahmedabad, Baroda and Surat Regions in Gujarat.
12.	Indore	Madhya Pradesh Region and the Zonal Training Institute, West Zone at Ujjain, MP
13.	Mumbai	Bandra, (Mumbai-I) and Pune Regions in Maharashtra.
14.	Nagpur	Nagpur, Thane, (Mumbai-II) and Kandivali (Mumbai-III) Regions in Maharashtra and Chhattisgarh Region.
15.	Jaipur	Rajasthan Region.

The above re-allocation of the jurisdictions will take effect immediately. All other instructions on drawing of pay and allowances of the IAP Team from the respective Headquarters, maintenance of Service Records and Leave Account etc. By the Regional Offices of the respective Headquarters of the Audit Party etc. shall remain unchanged.
