Sub:- **Formal identification of posts as sensitive or non-sensitive.**

On the recommendations of the Vigilance Division of Headquarters, Central P.F. Commissioner has approved the classification of posts as 'sensitive' or 'non-sensitive', which are as under:-

Posts	Sensitive	Non-Sensitive
EO/AO	Field postings of EOs with territorial jurisdiction over establishments, EO (Recovery).	Accounts Officers in-charge of Accounts Groups, PRO, EO (Legal).
APFC	Enforcement, Coverage, Recovery	HRM, Accounts, Damages, Pension, EDP, Cash, ZTI, NATRSS, CSD, Any functional area in HO other than HRM and Vigilance Directorate.
RPFC-II	OIC of a SRO, Enforcement, Coverage, Recovery, Vigilance Directorate (HO), HRM (HO).	HRM, Finance & Accounts, Damages, Pension, EDP, ZTI, NATRSS, CSD, Any functional area in HO other than HRM and Vigilance Directorate.
RPFC-I	OIC of a region, HRM (HO), Vigilance Directorate (HO).	ZTI, NATRSS, Head Office, Any functional area in HO other than HRM and Vigilance Directorate.
ACC	HRM (HO), Zonal Offices	NATRSS, Head Office.

Further, RC- I, RC - II and other officials dealing with procurement functions have been classified as 'Sensitive'.
