

No. P-IV/2 (6) 84/EPF Staff (CCA) Rules, 1971/Vol. II/ - In exercise of the powers conferred by Sub-Section 7 (a) of Section 5D of the Employees' Provident Fund & Miscellaneous Provisions Act, 1952 (19 of 1952) Central Board makes the following rules and further amends the Employees' Provident Fund Staff (Classification, Control and Appeal) Rules, 1971 namely:-

1. (i) These rules may be called Employees Provident Fund Staff (Classification, Control and Appeal) Rules, 2010.
(ii) They shall come into force from the date of their publication in the Official Gazette.
2. In the Employees' Provident Fund Staff (Classification, Control and Appeal) Rules, 1971, following entries shall be substituted/inserted in the Rules/Sub-Rules shown as below:-

Part - II - Rule 4 (i), (ii), (iii) and (iv) shall be substituted as follows: -
