Subject: Submission of RE 2011-12 and BE 2012-13 in respect of Employees' Provident Fund Scheme, 1952 (including EPS, 1995) and EDLI, 1976.

Sir,

Please refer to this Office Memorandum of even number dated 09.09.2011 and subsequent reminder dated 21.10.2011 calling for the proposals for Revised Estimates for the year 2011-12 and Budget Estimates for the year 2012-13.

2. The time limit prescribed for submission of the required information has already elapsed. The information pertaining to your Region is still awaited.
3. You are aware that the proposals for Revised Estimates and Budget Estimates on compilation have to be placed before the Central Board for approval and thus you were accordingly advised to submit the proposals by 15.10.2011. It seems no time bound action was initiated at your end to stick to the target date of submission of the proposals. Delay in submission has already delayed the compilation process at Head Office.
4. Thus, you are once again requested to take all out efforts to submit the proposals of Revised Estimate for 2011-12 and Budget Estimates for 2012-13 in the prescribed format after due verification of all the figures incorporated in the proposals. Whenever probable expenditure has come exorbitant, proper justification shall be recorded in writing while submitting the proposals.
5. The proposal of RE 2011-12 & BE 2012-13 are required to be placed before Finance & Investment Committee which is likely to be held in this month. After compilation of the same and on the basis of recommendations the same are required to be placed before ensuing CBT, EPF meeting for its recommendation.
6. In case, the details are already sent, this reminder may be ignored.
