Subject:- Declaration of results of EO/AO Examination held from 7th to 11th December, 2009 - for one vacancy in Gujarat kept pending due to OA Nos. 434 to 437 / 2009, CAT, Ahmedabad Bench .

Sir,

The result of the EO/AO examination held from 7th to 11th December, 2009 was announced for 25 candidates under General Category as against 26 vacancies due to OA.No. 434 to 437/2009 of CAT, Ahmedabad bench.

The applicants in thses OAs, Anilkumar Parmar alongwith 13 others were not eligible (as on 1.1.2009), as per recruitment rules to apply for the EO/AO Departmental examination for promotion. However, they were allowed due to the interim orders of the CAT. The results were not declared as the candidates were not eligible as per recruitment rules and the decision was pending.

The said OAs are dismissed by the CAT vide its common order dated 24.02.2011. The Hon'ble CAT has observed and ordered that;

"On examination facts of present cases, on touchstone of law relating to relaxation of Recruitment Rules as well as order dated 22.10.2010 of Jabalpur Bench (Deepak Kulkarni & Ors. V/s. Union of India & Ors.), we have no hesitation to hold that applicants were ineligible to appear in the departmental examination for the post of EO/AAO. We are also of the opinion that Tribunal cannot direct the concerned authority to relax the rules. No illegality or arbitrariness has been pointed out as well as established in prescribing the eligibility criteria laid down under statutory rules. Thus, finding no merits, OAs are dismissed."



The following candidate comes at the 26th position in merit order under General Category in Gujarat and is now to be declared successful in the EO/AO Departmental competitive examination for promotion against the examination conducted from 7th to 11th December, 2009.
