Please refer to the circular of even number dated 30.09.2011(SI. NO. 327 on website) on the subject cited above. In this regard it is observed that the instructions issued are not being complied with by many regions and incomplete information and references are being made to this office.

All the RPFCs are once again requested to kindly adhere to the instructions issued as reiterated as under :-

- A final decision regarding **eligibility of candidates** so far as **educational qualifications** are concerned based on the notified Recruitment Rules are to be taken by RPFC- I of the Region and RPFC-I of erstwhile region as per Para 5 & 6 of the circular dt 30.09.2011 since RPFC-I is the appointing authority for the cadre .
- The educational qualifications are to be verified from service book of the candidates and no certificates on eligibility may be issued with riders like original documents not verified etc. The certificate of eligibility issued by the RPFC-I will be taken as final by this office.
- The RPFC-I of erstwhile region should forward the **complete list of all candidates** of the **Political State** as per Para 6 of the circular dated 30.09.2011 in the format prescribed and not only for their particular office / region.

- The original applications of the candidates are to be retained by RPFC-I of erstwhile region and not forwarded to HQ.

It is further requested to kindly adhere to the time schedule given in the circular dt 30.09.2011.
