**Sub: SUPPLY OF INFORMATION UNDER RIGHT TO INFORMATION ACT, 2005**

Whereas Sh. S P Thirumuruga Kirubanandan has made a request in writing vide his/her application dated 1.8.2011, appeal dated nil and order dated 30.9.2011 of first Appellate Authority for obtaining information under Section 6(1) of the RTI Act, 2005.

2. Whereas the undersigned having been appointed as Central Public Information Officer under Section 5(1) of the said Act is required to consider and provide the information within 30 days of the receipt of the request.

3. And whereas Section 5(4) of the Act provides the Central Public Information Officer may seek the assistance of any other officer as he considers it necessary for the proper discharge of his duties. Sub-section (5) further provides that any officer whose assistance has been sought shall render all assistance to the Central Public Information Officer. Once the complaint is referred "for the purposes of any contravention of the provisions of the Act, such other officer shall be treated as Central Public Information Officer" and may be liable for penalties under Section 20 of the said Act. Further in the event of violation of provisions/non-furnishing of documents/information such an officer is liable for penalties under Section 20(1) of the Act @ Rs.250/- for each day of delay which may extend upto Rs. 25,000/-.

4. And whereas under Section 6(3) of Right to Information Act, it has been provided that:

"Where an application is made to a public authority requesting for an information:-

- (i) which is held by another public authority; or
- (ii) the subject matter of which is more closely connected with the functions of another public authority.

the public authority, to which such application is made, shall transfer the application or such part of it as may be appropriate to that other public authority and inform the applicant immediately about such transfer.”

5. Whereas on scrutiny of the application, I find that the information sought by the applicant on the following items:-

(i) Point No. 2 under column no. 3, 4 & 5

is closely related to and held by the CPIOs of all the Regional P. F. Commissioners-I (All regions including RPFC (ASD)/ZTIs), the undersigned invokes the provisions of section 5(4) of the said ACT and transfer the application to furnish the information/documents sought by the applicant under the Act within 7 days of the receipt of this communication directly to the applicant under intimation to the undersigned. You may please note that any delay in furnishing the information/documents sought for within the stipulate time will attract the penal provision as provided for under Section 20 of the Right to Information Act.

6. This may please be treated as MOST URGENT.

The CPIO has failed to furnish the required information, Hence I prefer this appeal.

1. Point No 2.Column no 3

I requested the CPIO to furnish the Pay band, Basic pay and Grade pay as on 01.08.2011 of the DPA's, but the payband and grade pay particulars alone were given. The Basic Pay details of each DPA was not given.

2. Point No.2 Column no 4

I requested the CPIO to furnish Date of assumption of charges and date from which arrears was paid to each DPAs, but CPIO furnish only the date of assumption of charge and he failed to furnish the information regarding the date from which pay fixation arrears were given.

3. Point No.2 column no 5.

I requested the CPIO to furnish the particulars about the date from which suitcase and paper allowance given to DPA. But the CPIO replied that no such information is available. In this regard I am given to understand that the suitcase allowance was paid to the 10 DPAs working at Head office vide Office order No ASD-II/75(I)95/II/635 dated 30/05/2011.

In this connection I humbly request the appellant authority to furnish the complete information requested by me.


