Sir,

Attention Reference is invited to MIS Section letter of even No. dated 5<sup>th</sup> May 2011 and 20<sup>th</sup> May 2011 (**Sl. No.63 & 97 of EPFO's website**) vide which all the CPIOs in ROs and SROs were requested to confirm that the information has been provided to Shri Akshay Kumar Malhotra, applicant under the RTI Act, 2005 in compliance with the orders of CIC in case No CIC/SG/A/2011/00523/12248. It is noted that as on date 19<sup>th</sup> offices yet to confirm that the correct and complete information has been sent by Speed Post to the appellant. A list of 20 offices may be seen in the **Annexure - A**.

It may further be mentioned that the CPIOs in respect of certain ROs and SROs who had not provided the information within the stipulated period are required to be present before the CIC on 3<sup>rd</sup> June 2011 at 4 p.m. Therefore it may be ensured that the CPIOs also attend the hearing on the scheduled date as per the directions of the CIC and shall also bring the information sent to the appellant and submit Speed Post receipt of having sent the information to the appellant in accordance with the orders of the CIC. A list of 17 CPIOs who have to attend the hearing may be seen in **Annexure-B**.

As has been already requested, a copy of the information sent to the appellant by all the CPIOs in ROs/SROs may be also endorsed copies to MIS Section at Hqrs. at [rc.mis@epfindia.gov.in](mailto:rc.mis@epfindia.gov.in) alongwith the certification that the information is complete in all respects, the opening and closing balance in each month tallies and there are no arithmetical and factual errors. But the same is till awaited from officers listed at Annexure-A. This information is necessarily required to comply with the directions of CIC at Headquarters level.

4. You are requested to ensure submission of information immediately with explanation of concerned RPF/CPIO for non-adherence to the time line given in such important matter.
