OFFICE ORDER

A review DPC was conducted on 12.09.2011 to review the original DPC held on 28.06.2011 to consider the regular promotion of the following officers to the post of RPFC Grade II in the pay band 3 (Rs. 15600-39100 with GP Rs. 6600). 2. As the above promotion would be on a notional basis, the officers concerned can opt for the pay fixation from the date of notional promotion. However, they would be entitled to arrears only from the date of actual assumption of charge on the post of Regional Provident Fund Commissioner Grade II.

3. On promotion, the officers may be relieved of their duties within three days of receipt of the orders with directions to report for duty at the new place of posting. On transfer the officers would be eligible for transfer TA/DA as admissible under the rules wherever applicable.

3. The seniority of the officers will be regulated in the cadre of Regional PF Commissioner Grade II, as per the provisions of EPF Staff (Fixation of Seniority) Regulations 1989.
