2 The place of posting to the offices within the specified Region would be decided by the Additional Central Provident Fund Commissioner of the concerned political State who would issue the posting orders in respect of the above official and would directly intimate the officials through their RPF-C-I (in-charge of the Region) The postings of DPA's in Regional & Sub-Regional offices would be subject to the

approved norm of maximum 2 (two) DPA's per each office (Regional office/Sub-Regional office)

3. The officials shall be advised to report directly to their respective place of postings.
4. The appointment would be without prejudice to the seniority and claim for promotion on regular basis of all other eligible officials and it will neither confer on them any rights to claim for promotion on regular basis, or seniority in the post of DPA.
5. On posting the officials would be eligible for transfer TA/DA and joining time as admissible under the rules wherever applicable.
6. The Head office to be intimated about the postings and joining of the DPA's.
