3. The Vehicle shall be sold to the highest bidder.
4. The successful bidder has to make full payment through Demand Draft in favour of "Regional Provident Fund Commissioner, Shimla" within three days after confirmation, failing which the offer will be cancelled/rejected.
5. The Vehicle sold to the successful bidder shall not be taken back by the office under any circumstances.
6. The successful bidder will be required to lift the Vehicle from the disposal site within

8. Quotation if found to be below the Reserved Price fixed by this office shall not be accepted.
9. Quotations should be submitted in sealed cover on or before 30.01.2018 by 2:00 PM to this office. This office will not be responsible for any delay due to postal authorities or any other reason.
10. Received bids shall be opened on 30.01.2018 at 2:30 PM at office address mentioned above. The bidders/interested parties may choose to be present during the opening of bids either themselves or through authorized representatives.
11. Each paper or quotation should be signed by the bidders. The bid should specify the quoted amount in both figures and words. Any overwriting or erasing in the figures or words shall not be considered for acceptance of the rates offered by the bidder.
12. Bidder must enclose a copy of Address Proof and PAN Card/Aadhar Card along with their bid.
13. If any controversy arises, the decision of the Regional Provident Fund Commissioner-I, EPFO, Regional Office, Shimla will be final. The Regional PF Commissioner-I will have the right to reject any or highest bid without assigning any reason.
