The conditions for the tender are as below:-

1. This office shall pay maximum of Rs. 36000/- per month plus applicable service tax/toll taxes extra.
2. The organization shall deduct the TDS on monthly charge.
3. The rate shall include the vehicle with licensed driver, fuel, maintenance and any other scheduled charges.
4. The vehicle has to be in good working condition preferably a model of manufacturing not more than 2 years in case of breakdown, replacement has to be made with similar or higher category of vehicle. No overtime charges or night charges or any additional charge would be paid.
5. The bidder shall enclose an account payee demand draft of Rs. 5,000/- as Bid Security drawn in favour of "**Regional P F Commissioner , Vashi**". Bid security to remain valid for a period of 45 days beyond the final bid validity period.
6. The vehicle will not be used by the vendor for any other purpose other than as required by the Employees' PF Organisation during the period of contract.
7. The rate will not be revised upwards in any condition.
8. The vehicle must have insurance cover fulfilling pollution control norms and all other requirements as per law.
9. The counting of distance for all purpose will be from the office premises.
10. The controlling officer of the vehicle will be Assistant P. F. Commissioner (ADM).
11. The payment will be made on completion of the month on submission of your bill to the respective office.
12. Vehicle shall be available in all days of the week, only one day in the week can be given as weekly off.
13. Mobile to the driver and its refilling charge shall be paid by vendor.
14. The vehicle should have commercial registration.
15. The contract can be terminated in the event of the breach of any of the above conditions.
16. Declaration by the vendor to abide by all the conditions mentioned in the tender or any other condition imposed by the office shall be submitted as part of the tender.
17. **The competition will be decided on the basis of maximum kilometers per month offered by the vendor.**
18. Continuity of same Vehicle & Driver for the period of contract.
The office reserves the right to accept or reject any or all the quotations without assigning any reason thereof.
